All the ordinary resolutions were duly passed as more than 50% of the votes were cast in favour of each of the ordinary resolutions.

As at the date of the AGM, the total number of Shares in issue was 873,111,452 Shares. At the AGM, there was no Share of the holder that was required under the Listing Rules to abstain from voting on any of the ordinary resolutions, and there was also no Share entitling the holder to attend and abstain from voting in favour of any of the ordinary resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. Accordingly, the total number of Shares entitling the holder to attend and vote for or against the ordinary resolutions at the AGM was 873,111,452 Shares, representing 100% of the total issued share capital of the Company as at the date of the AGM.

Tricor Tengis Limited, the branch share registrar and transfer office of the Company in Hong Kong, was appointed as the scrutineer for the vote-taking at the AGM.

No party has stated its intention in the Circular that it would vote against any resolutions or that it would abstain from voting at the AGM.
