**APPOINTMENT OF
BLACKBIRD TRIDENTE AS IMPORTER AND DISTRIBUTOR OF
MASERATI IN HONG KONG AND MACAU**

This announcement is made by CCT Fortis Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) on a voluntary basis.

The board of directors of the Company (the “**Board**”) is pleased to announce that definitive agreements relating to the Maserati importership have been entered into between Maserati S.p.A (“**Maserati**”) and Blackbird Tridente Company Limited (“**Blackbird Tridente**”), pursuant to which Blackbird Tridente has been appointed as the official importer and distributor for Maserati vehicles and the provider of after-sales services in Hong Kong and Macau (the “**Importership Appointment**”).

Maserati is a world famous manufacturer of high performance luxury cars. Blackbird Tridente of the Blackbird Automotive Group, is an indirect wholly-owned subsidiary of the Company. The Blackbird Automotive Group, led by its CEO Mr. TK Mak, is an operations group of the Company, which is engaged in automotive business.

The Board considers that this Importership Appointment represents another major milestone of the Blackbird Automotive Group in the development of its automotive business globally. Maserati is investing in both hybrid and electric vehicle development which align with the Group’s own visionary strategies. Combined with its Ferrari dealership business in Hong Kong and Macau, this Importership Appointment will enable the Blackbird Automotive Group to expand into the large dealership business of Maserati’s luxury cars and hence will enhance the reputation and status of the Blackbird Automotive Group in the global automotive sector. The Board also believes that this Importership Appointment will contribute a stream of significant revenue to the Group and will open up a new avenue for

growth of income and profit.
