Remarks:

On 18 August 2023, 4.5% coupon convertible bonds due on 18 August 2024 with the aggregate principal amount of HK\$30,011,500 at initial conversion price of HK\$0.193 per conversion share was issued under general mandate, of which the partial principal amount of HK\$10,000,000 was redeemed on 18 February 2024. The Company had redeemed an aggregate principal amount of HK\$13,256,500 at maturity and the aggregate outstanding principal amount of the remaining convertible bonds of HK\$6,755,000 has been extended for one (1) year to 18 August 2025 with the interest rate of the convertible bonds amended from 4.5% to 9.0% per annum, and the conversion price of the convertible bonds was amended from HK\$0.193 to HK\$0.15 per conversion share.

All other terms and conditions of the convertible bonds remain unchanged. Details are set out to the announcements of the Company dated 19 August 2024 and 27 August 2024."
